E-AUCTION NOTICE

It is hereby notified for information of the General Public that the following 53 nos. green/dry/standing/fallentrees of different kinds on defence land located at proposed site between alignment of security of wall under construction and boundary fencing of Military Station Fazilka will be disposed off through e-auction. The e-auction shall be uploaded on or after **25.06.2021** on online portal of Government e-auction System web <https://eauction.gov.in/eAuction/app>. The trees will be shown on **28.06.2021** at 1100 hrs. The intending bidders will be allowed to visit and inspect the said trees and location in consultation with Local Military Authority.

TERMS AND CONDITIONS

a) The intending bidder will have to submit Rs.15,000/- (Rupees Fifteen Thousand only) as earnest money in the shape of Demand Draft/Bankers Cheque drawn in favour of **Defence Estates Officer, Bathinda** payable at Bathinda from any Nationalized Bank on or after online publication. Above said Demand Draft/Bankers Cheque must be issued on or after date of online publication of this notice and shall be refunded soon after the completion of e-auction proceedings except in the case of the highest bidders whose earnest money shall (as the case may be) be adjusted against the 1/4th (25%) bid money. The Demand Draft/Bankers Cheque of 1st highest bidder will also be retained. Only those bidders/contractors will be considered eligible for participating in e-auction who will produce hard copy of PAN card, residential proof (Aadhar card/Voter's card/Passport/Drivers' License) and original copy of above said Demand Draft/Bankers Cheque including other

documents as mentioned in **Annexure "B"** and E-auction Form in **Annexure "C"** for verification.

b) The highest bidder shall after being declared successful, deposit the 1/4th amount of the highest bid money within 01 week immediately otherwise earnest money will be forfeited and remaining 3/4th bid money within 07 days of the communication of the acceptance of the his/her bid by higher authority in the **Public Fund Account** of the **Defence Estates Officer, Bathinda** through RTGS/NEFT (Account No.65020559620,IFSC- SBIN0050038, Branch Code- 50038 Bank-SBI, Branch- **Civil Lines, Bathinda**). After deposit of above amount, each proof of the same should be provided to the office of the Defence Estates Officer, Bathinda (hereinafter called DEO, Bathinda). In case the bid money is not deposited within the stipulated period Earnest Money or 25% or both whichever the case may be already deposited shall be forfeited and Highest bidder may be considered as successful bidder. In the event, numbers of participants are less than 03 (three), documents/payments will be rejected and e-auction will be treated as cancelled at this very stage.

c) Any bidder found indulging either directly or indirectly in unfair means adversely affecting the auction process will be liable to the legal and punitive action. Such bidder will also be liable to be debarred from further auction proceedings besides being blacklisted in future e-auction or open auction.

d) The highest bid will be subject to the approval of the competent authority through official hierarchy.

e) The trees will be cut/removed by the highest bidder whose bid will be accepted (hereinafter called successful bidder) contractor within **10 days** from the issue of acceptance of the bid and issue of the permission letter.

f) The Successful bidder will have to deposit security deposit equal to 10% of his/her bid through FD/FDR of Nationalized Bank duly pledged in favour of **Defence Estates Officer, Bathinda** which will be refunded to him after the successful completion of the work and in the event of there being no damages to the Govt. property in the process of cutting of trees. The security deposit will be liable to be forfeited in case of violations of any of the conditions contained in the notice. Further, all the uncut/standing trees shall become the property of Govt. of India in case of violation of any of terms and conditions. DEO, Bathinda further reserves the right to impose any such amount as damages charges as deemed fit in case of any illegal cutting of trees i.e. in the case of contractor/successful bidder or his workmen were found cutting any other tree other than what was put to auction, the contractor shall have to deposit the damage charges within 10 days of issue of such letter from the office of DEO, Bathinda. In case of default, the damage charges shall be recovered as per statutes.

g) The successful bidder will have to cut the trees according to the instructions given by the DEO, Bathinda or his rep. The trees will be removed with their roots from the site and pits filled up to ground level. The trees would be allowed to be cut between 09:00 AM and 05:00 PM only on working days except holidays.

- h) The contractor shall not assign or sublet the contract.
- i) The successful bidder will surrender the original cash receipt otherwise security will not be refunded.
- j) The trees should be cut within the specified period failing which the sanction will be liable to be withdrawn and the successful bidder will forfeit his claim over the trees/branches which could not be removed unless valid reason for the delay have been shown to DEO, Bathinda and the same were accepted by DEO, Bathinda. The decision of DEO, Bathinda shall be final and binding on the successful bidder. The DEO, Bathinda will have a right to dispose off those forfeited trees in the manner as deemed fit and the successful bidder will have no claim over the material so disposed off. In extreme circumstances, the extension will be granted.
- k) The successful bidder will be responsible for any damages caused to Govt. property such as building/Electric wires etc. and cost of such damages as assessed by the DEO, Bathinda will be recoverable from the bidder. The decision of the DEO, Bathinda in this regard shall be final.
- l) The competent authority reserves the right to accept or reject any bid at any stage without assigning any reason and the right to change and add in clause of these terms and conditions.
- m) The successful bidder (the highest bidder whose bid will be accepted by competent authority) shall be liable to deposit any rates/levies/charges/taxes etc payable under the provision of any law prevalent. The bid amount is exclusive of all those rates/levies/charges/taxes etc. MRP preparation charges will be borne by the successful bidder.
- n) No claim after the cancellation of bid proceedings will be entertained.
- o) Laborers and their supervisors to be employed for cutting of trees will be allowed entry into the area on passes. The successful bidder will be required to submit a list of workmen proposed to be employed with their residential addresses to the DEO, Bathinda as well as to the Station HQrs/Commanding Officer of the unit/area alongwith necessary police verification report from security point of view etc. The DEO, Bathinda and Station Commander of the area reserve the right to permit only those laborers/supervisors who have been verified by the Police authorities from security point of view. The decision of the DEO, Bathinda in this regard shall be final and binding.
- p) The successful bidder shall be personally responsible for implementation of all the provisions of minimum wages act, worker compensation act and shall indemnify Govt. of India in this regard.
- q) All security measures/precautions required to be observed in the prohibited area will be followed by the successful bidder and workers/men employed by him.

r) Only the successful bidder will be allowed to supervise the cutting of the trees and any power of attorney/authorization in favour of any other person will not be entertained.

s) No cutting will be allowed on Sunday and Holiday and before Sunrise and after Sunset without the permission of Local Military Authorities.

t) In case of any dispute arising from the said e-auction, the decision of the DEO, Bathinda will be final and applicable. The judicial jurisdiction of any of dispute will be at Bathinda, Punjab. In case, any dispute remains undecided, such dispute or difference shall be referred to the arbitration of the Principal Director, Defence Estates, South-Western Command (PDDE, SWC). The decision of PDDE, SWC shall be final and binding on the parties thereto. The provisions of Arbitration and Conciliation Act, 1996 and the rules thereunder shall be deemed to apply to the arbitration proceedings under this clause. The award of the arbitrator shall be enforceable in Bathinda Courts only.

u) Any contractor/bidder participating in e-auction proceeding will be considered that he/she is fully aware and agrees to all the clauses of these TERMS and CONDITIONS.


