7. This office or its officials shall not be, in any way, responsible for failure to take delivery of the articles due to causes beyond its control such as lockdown, force majeure etc.
8. Delivery shall be taken by the H-1 or its duly authorized representative in the presence of the Store Keeper.
9. The Lot has to be lifted by the H-1 at his/her own expenses.
10. The Board/ CEO reserves the right to accept or reject any or all bids without assigning any reason whatsoever.
11. No negotiation whatsoever shall be held with the H-1/bidders.
12. No bidder shall be allowed to participate in the e-Auction whose arrears pending towards the Cantonment Board. In this regard, the bidder shall be required to submit an affidavit duly attested by the Notary.
