## TERMS AND CONDITIONS OF ADVERTISEMENT CONTRAT ON 20 NOS. OF BARIGATES IN CANTONMENT BOARD AREA: AUCTION ON 01.12.2023 AT 10.30 HRS.

- 1. The amount will be received in advance on quarterly basis.
- 2. The decision on the offers would be given by the Chief Executive Officer/Cantt. Board.
- 3. The highest bidder will be required to execute an agreement within 07 days after the sanction of highest bid by the Cantonment Board, Ambala.
- 4. The earnest money will be deposit Rs.5000/- by on-line and three month licence fee as security on line deposit at the fall of hammer.
- 5. The amount of Rs.50,000/- of security will be refunded after the tenure of contract without interest and if during the tenure of contract any loss or damage is caused to the Cantonment Board.
